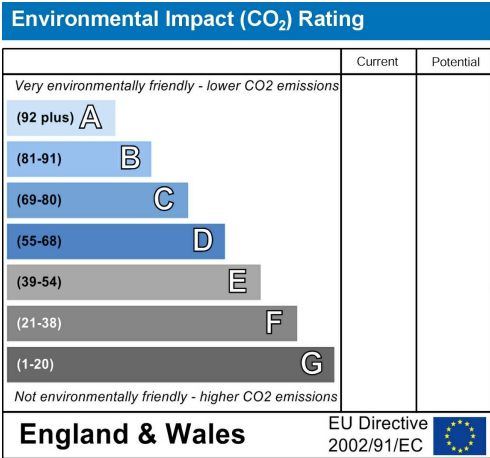
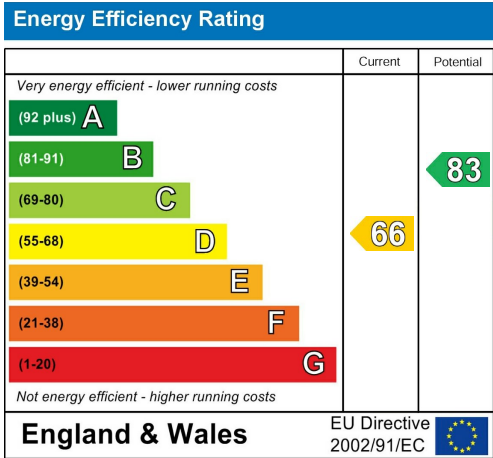


Energy Efficiency Graph
