Tenure (Freehold).

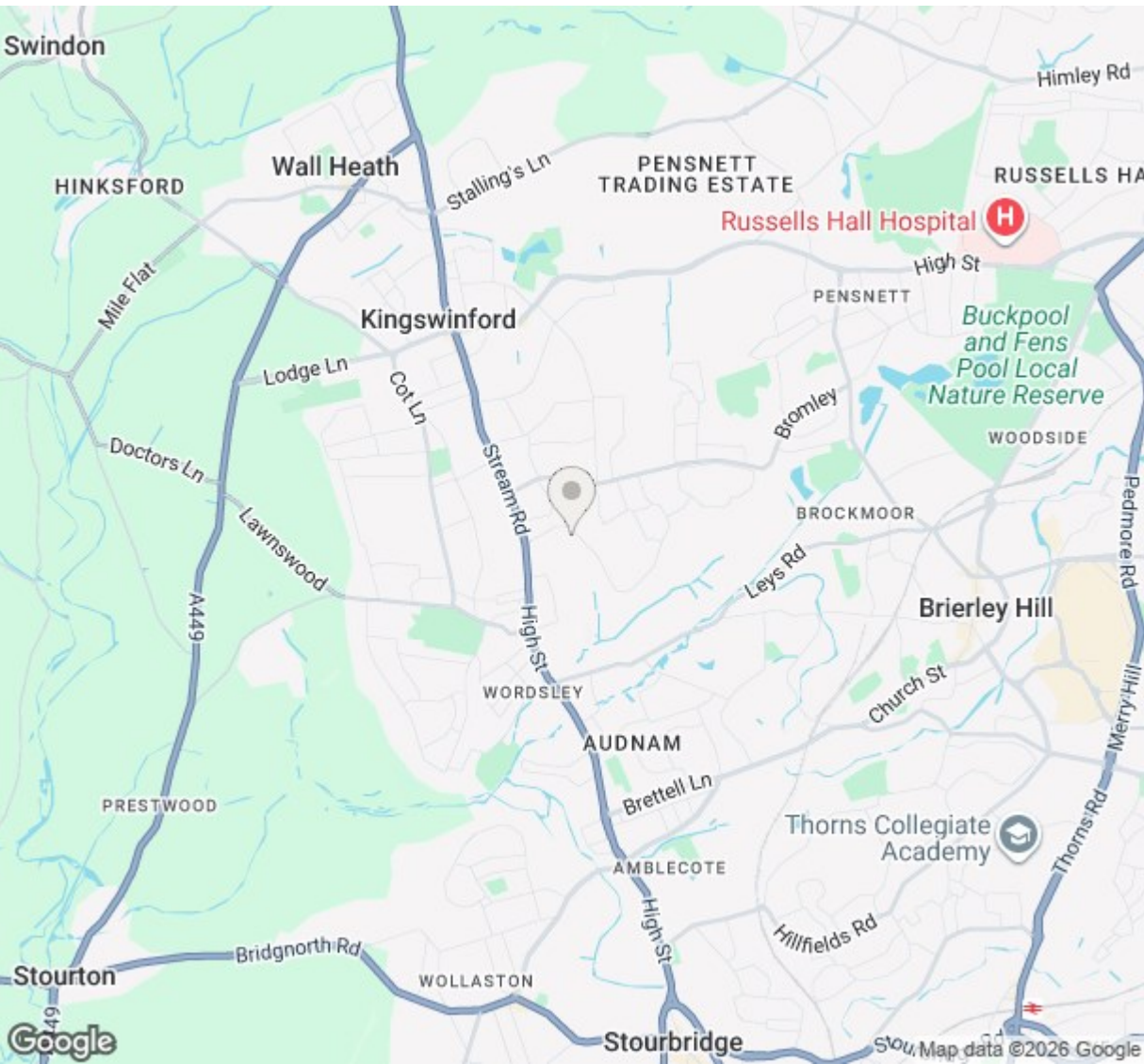
References to the tenure of a property are based on information supplied by the seller. We are advised that the property is freehold. A buyer is advised to obtain verification from their solicitor.

There is a service charge of £162.21 to be paid annually. This is for the upkeep of the private road.

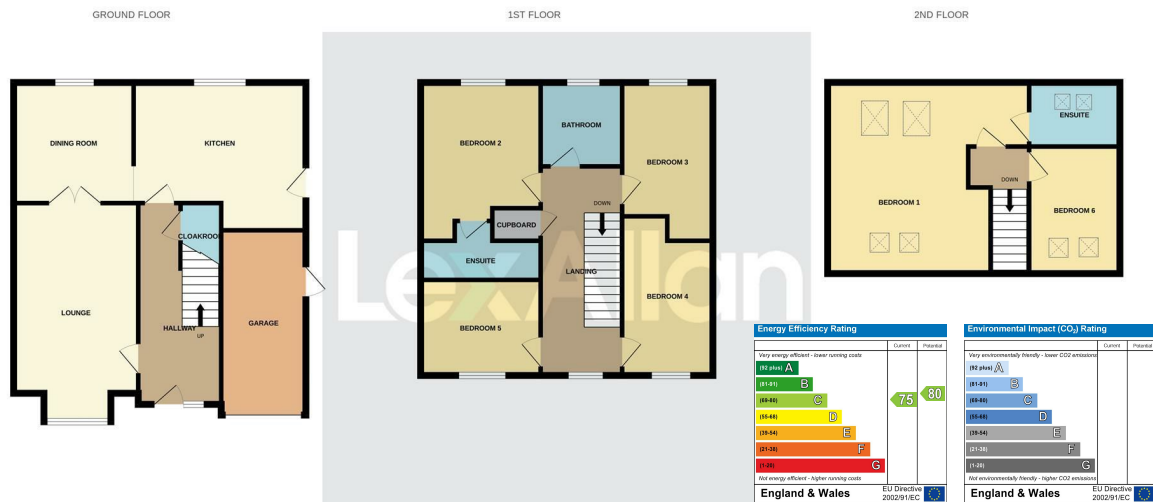
