Approach

Access via communal front door with video entry facility opening into communal hallway.

Entrance Hall

Spacious hall with doors off to all accommodation, large storage cupboard housing the washing machine & dryer, central heated radiator.

Lounge/Diner

French door to slabbed perimeter, two radiators, opening to the kitchen.

Kitchen

Modern fitted kitchen offering wall & base units, integrated fridge/freezer undercounter & washing machine, electric oven, hob with extractor over, ceramic sink & drainer with mixer tap, double glazed window to side, spot lights.
