Approach

Block paved drive to front offering parking for a number of cars, flower bed and slate chip bedding.

Entrance Hall

Double glazed window and door to front and central heating radiator.

Lounge

11' 5" x 17' 4" (3.5 x 5.3)

Double glazed window to front, central heating radiator and gas fire.

Kitchen

11' 1" x 9' 10" (3.4 x 3.0)

Range of wall and base units with work surface over incorporating sink with mixer tap, gas hob with extractor hood over, integrated oven, dishwasher, space and plumbing for washing machine, central heating radiator and tile splash backs.

Dining Room

8' 10" x 9' 6" (2.7 x 2.9)

Double doors to conservatory and central heating radiator.

Conservatory

10' 9" x 11' 1" (3.3 x 3.4)

Double glazed windows and doors with electric blinds, central heating radiator and tile floor.

Inner Hallway

Cupboards and doors off, central heating radiator and access to loft space.

Bedroom One

Double glazed window to rear and central heating radiator.

Bedroom Two

Double glazed window to side and central heating radiator.

Double glazed window to side, shower, wash hand basin, WC, central heating radiator and tile splash backs.

Garage

Main door to front and inner rear door to hallway.

Patio area, flower bed, side gate and walls and fencing to enclose.

References to the tenure of a property are based on information supplied by the seller. We are advised that the property is freehold. A buyer is advised to obtain verification from their solicitor.

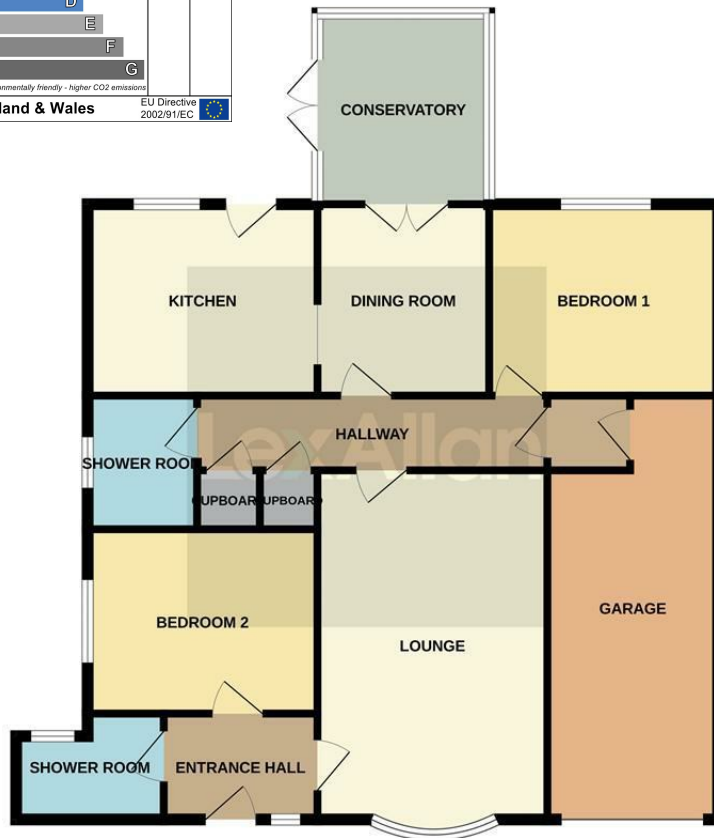
