Approach

The development is accessed via a secure electric barrier where a code entry is required leading you to the communal car park. The property has its down private access door off the communal garden.

Entrance Hall

With cupboard and doors off.

Lounge/Diner

13' 1" max 8' 10" min x 17' 8" (4.0 max 2.7 min x 5.4)

Electric heater, double glazed window and door to front opening onto communal gardens.

Kitchen

5' 6" x 8' 10" (1.7 x 2.7)

Double glazed window to front, range of wall and base units with work surface over incorporating sink with mixer tap, electric hob with extractor hood over, oven, fridge, freezer, tiled floor and splash backs.

Bedroom

10' 2" x 13' 9" min 15' 5" max (3.1 x 4.2 min 4.7 max)

Double glazed window to front, electric heater and fitted wardrobe.

Bathroom

WC, easy access bath with shower over, wash hand basin with storage below, tiled floor and splash backs, electric fan heater and extractor fan.

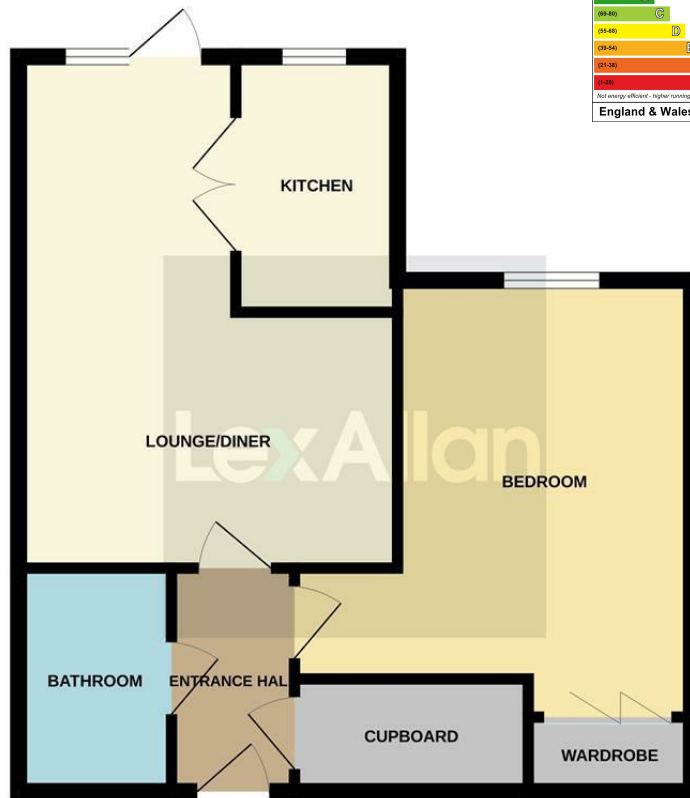
Tenure (Leasehold).
