Entrance Hall

Door to front, central heating radiator and stairs off.

Downstairs WC

Double glazed window to front, WC, wash hand basin, tiled splash back and central heating radiator.

Central heating radiator, double glazed window to front and gas fire.

Dining Room

Sliding door to rear and central heating radiator.

Double glazed window to rear, range of wall and base units with work surface over incorporating sink with mixer tap, space and plumbing for washing machine, tiled splash backs, extractor hood, central heating radiator and cupboard off.


