Block paved drive offering parking for a number of cars, steps up to front and lawn.

Hallway

Door to side, central heating radiator and stairs off.

Lounge

Double glazed window to front and side, central heating radiator and gas fire.

Kitchen

Double glazed window to rear, French doors to garden, range of wall and base units with work surface over incorporating sink with mixer tap, induction hob with extractor hood over, integrated fridge, freezer, dishwasher, tile splash backs, central heating radiator and cupboard off.

Landing

Access to loft space and door off.

Bedroom One

10'9" x 9'6" (3.3 x 2.9)

Double glazed window to front and side with far reaching views, central heating wardrobe and fitted wardrobe.

Bedroom Two

10'2" x 9'6" (3.1 x 2.9)

Double glazed window to rear and central heating radiator.



Bedroom Three

5' 10" x 7' 10" (1.8 x 2.4)

Double glazed window to front and central heating radiator.

Bathroom

Double glazed window to rear, bath with mixer tap and shower over, WC, heated towel rail, wash hand basin with mixer tap and storage below and tile splash backs.

Referral Fees.

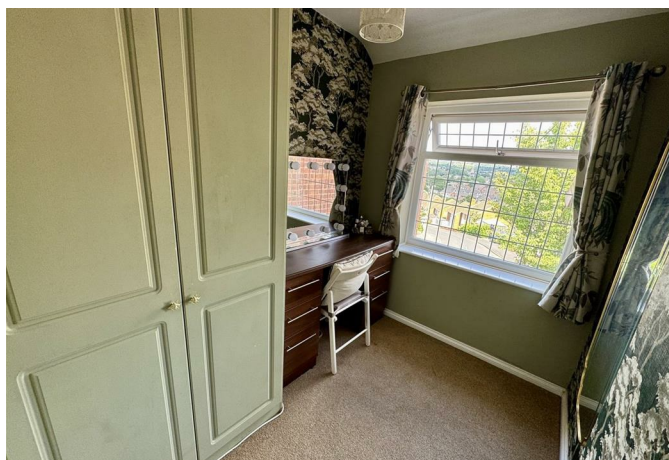

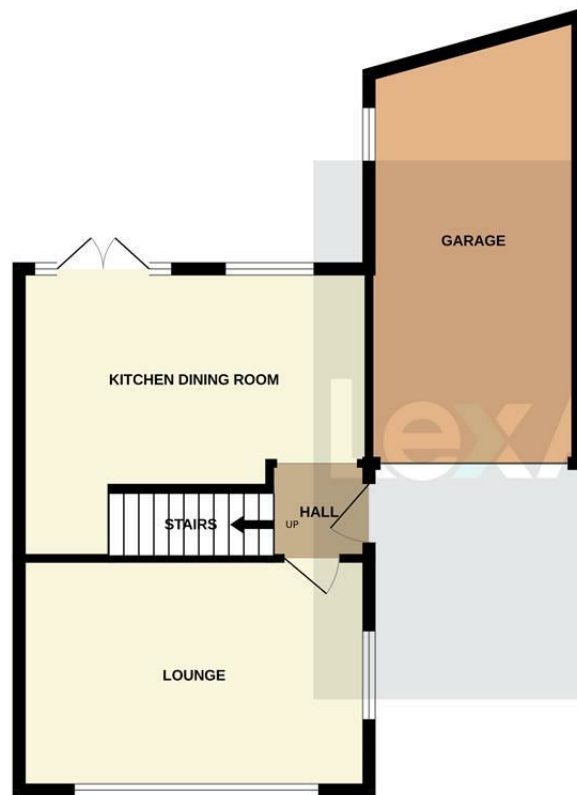

Tenure (Freehold).

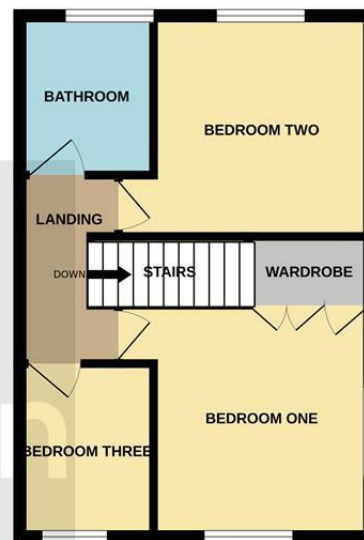
References to the tenure of a property are based on information supplied by the seller. We are advised that the property is freehold. A buyer is advised to obtain verification from their solicitor.
