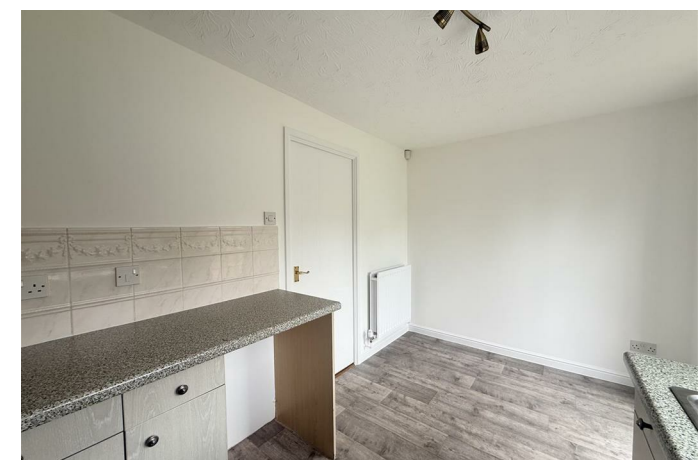
Landing

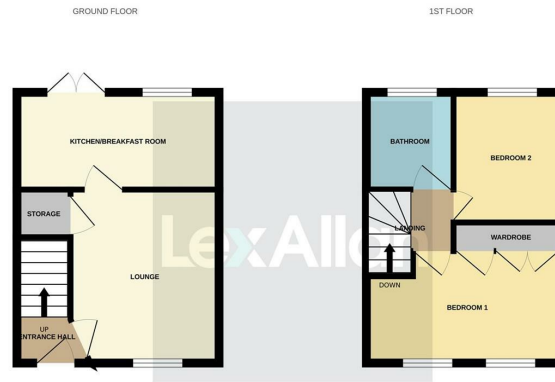
