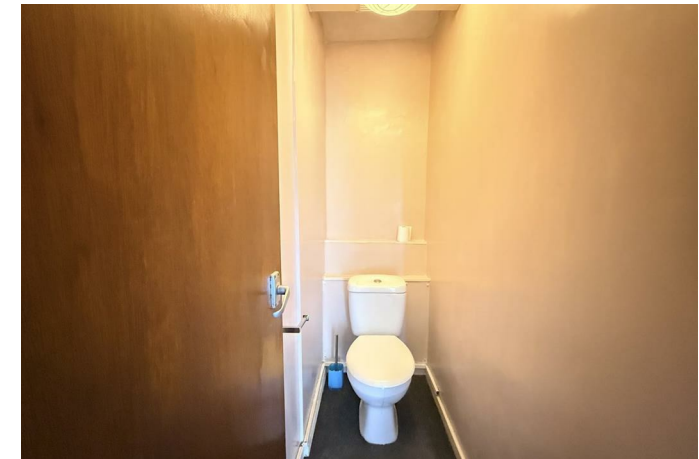

Referral Fees.

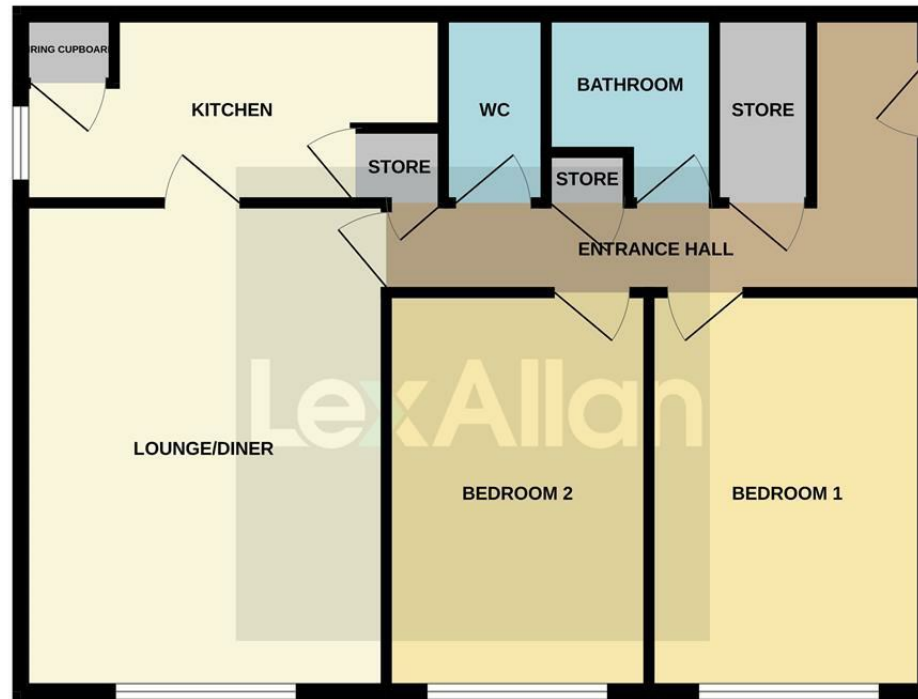
