Communal Hall

Well maintained hall with door off to our ground floor flat, access to the additional storage cupboard.

Entrance Hall

Spacious hall with doors off to all accommodation, airing cupboard, central heated radiator.

Lounge

Gas fire with surround, large double glazed window to front, opening to the kitchen.

Kitchen/Breakfast Room

Tenure (Leasehold).

Referral Fees.

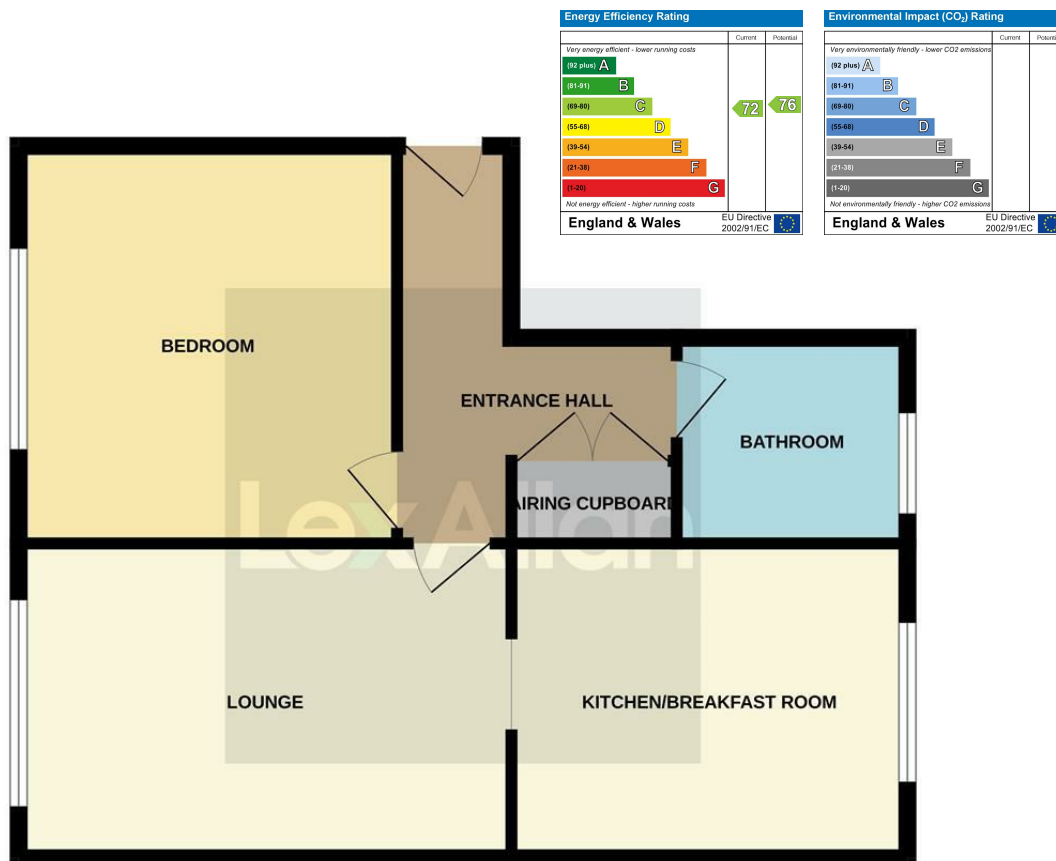
