Money Laundering Regulations.

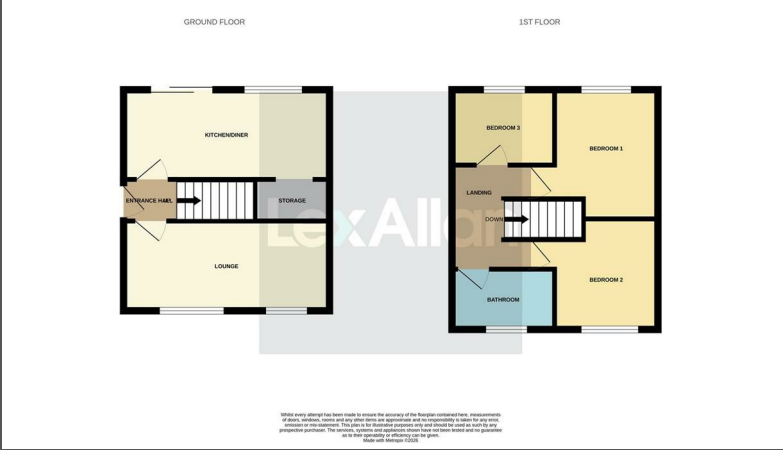

Referral Fees.
