Block paved drive to front providing off road parking

Entrance Hall

Door off to lounge, under stair storage cupboard, double glazed window to side, stairs rise to first floor, central heated radiator.

Lounge/Diner

Centred electric fire with surround, double glazed bay window to front, door off to kitchen, two central heated radiators, spot lights, double doors off to conservatory.
