Upon entry, the bungalow opens into an entrance hall, leading straight through to the generously sized lounge. This offers excellent space for comfort, family entertaining, and dining, and features a fireplace and French doors opening into the conservatory, allowing plenty of natural light to flow through. From the lounge, you can access the kitchen, which is fitted with ample storage and worktop space, as well as under-counter space for freestanding appliances, and the conservatory — a great space for relaxation in the warmer months, with a door providing access to the rear garden.

Returning through the lounge, you will find bedroom one, a spacious double with fitted sliding-door wardrobes. The hallway then leads to bedroom two, which can accommodate a small double or a generous single, along with a storage cupboard and the bathroom. The bathroom is fitted with a WC, wash basin set within a vanity unit, and a shower cubicle, with a convenient loft hatch situated above.

The rear garden begins with a small patio area, with a pathway providing access to the garage as well as the gate leading back to the front of the property. Steps then lead up to a walkway bordered with plants and shrubbery, opening onto a large green space at the top that adds character to the garden.
