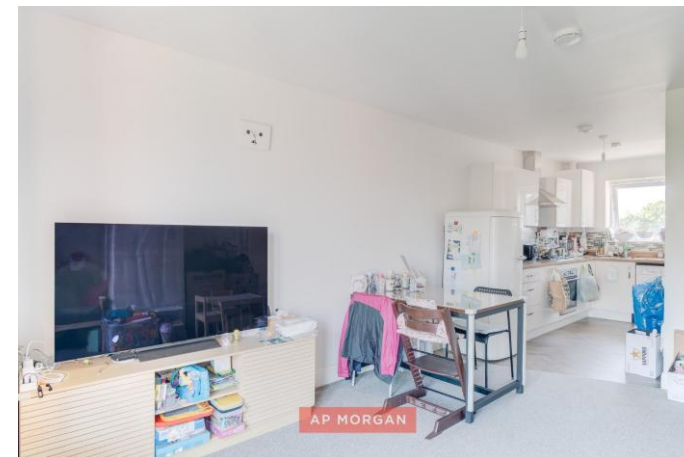
The apartment features two generously sized bedrooms serviced by the family bathroom, completing the accommodation.
